

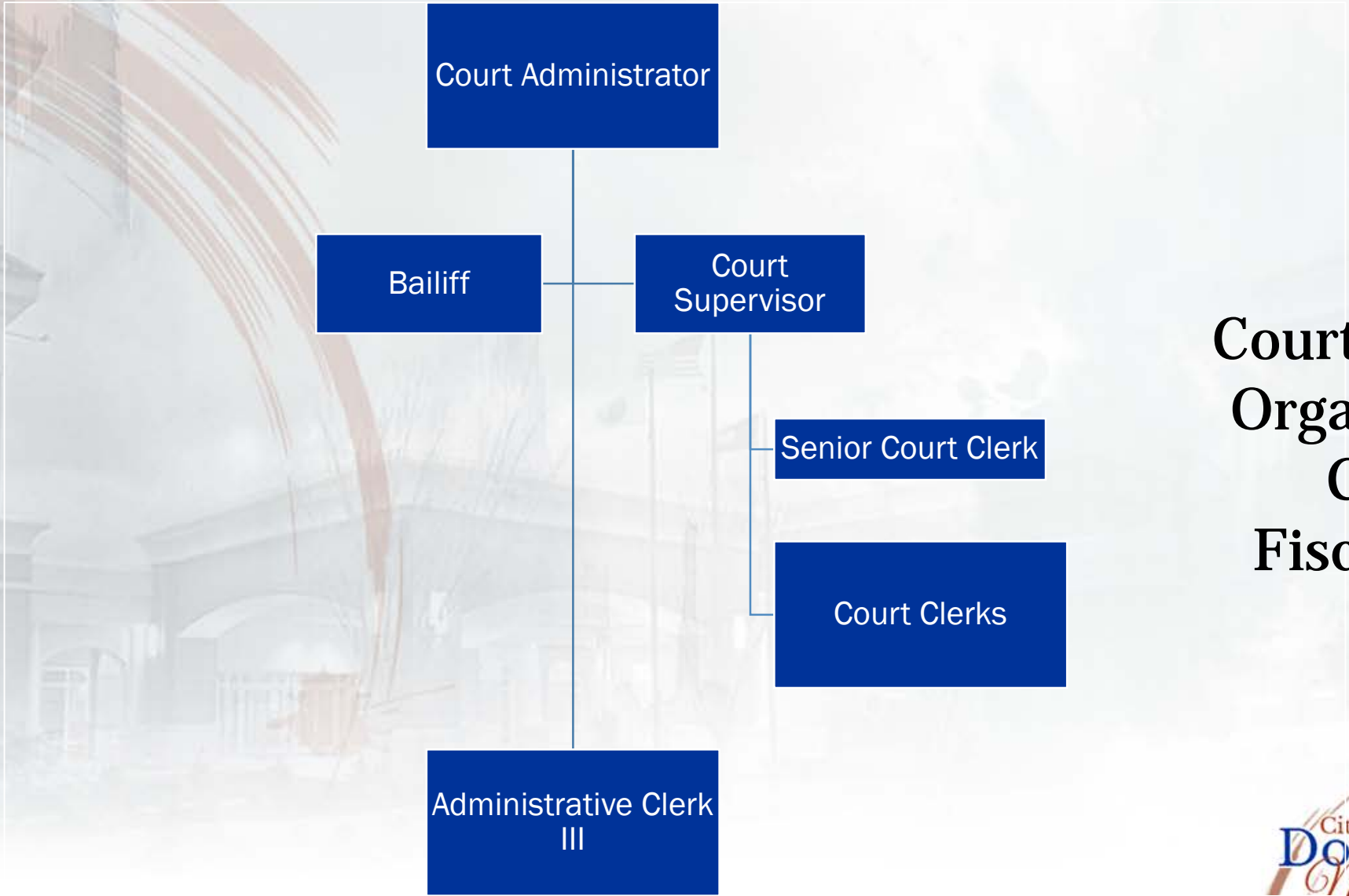

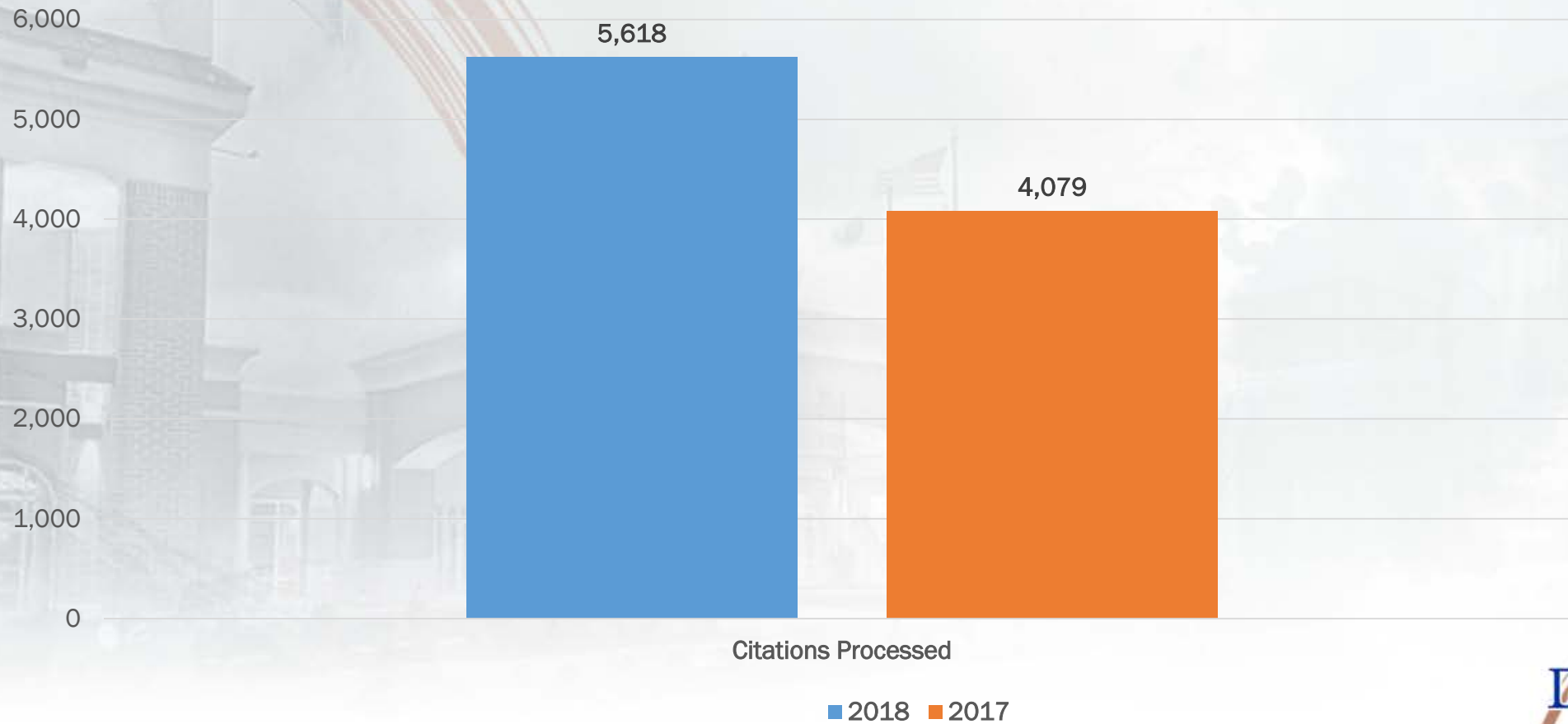
# Court Services Organization Chart Fiscal 2019





# Total Citations Processed 2018 versus 2017

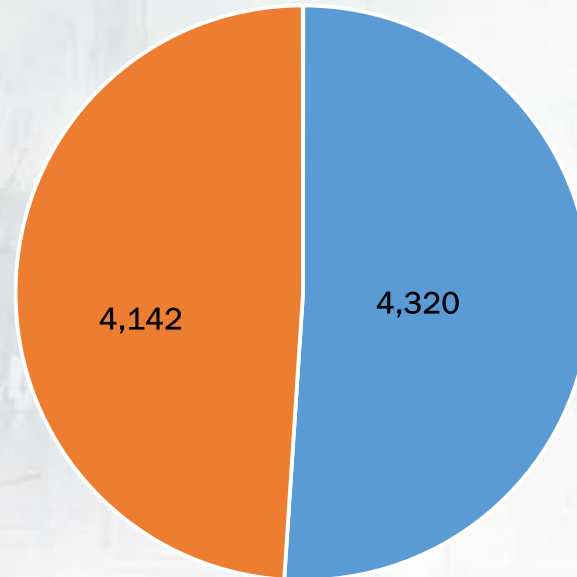

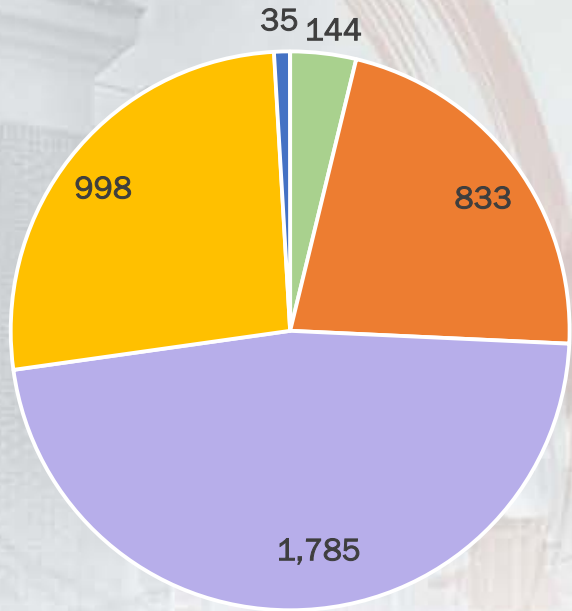

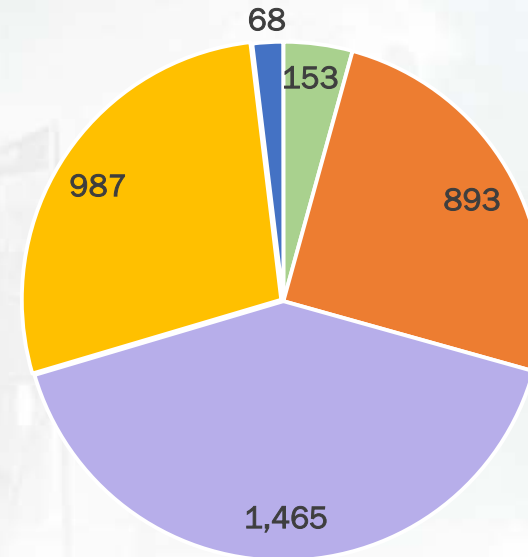

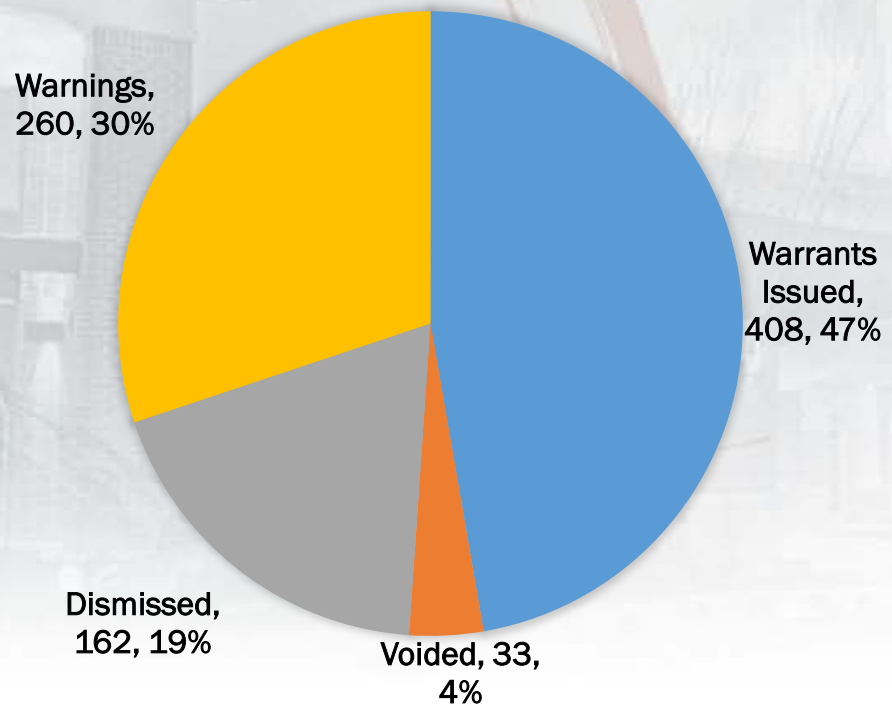

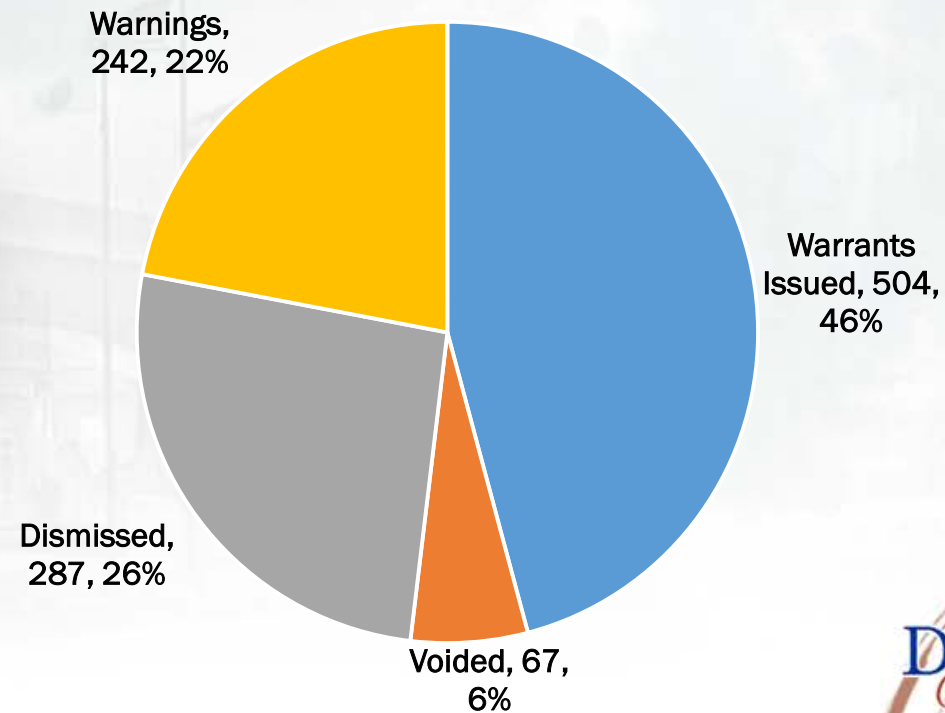

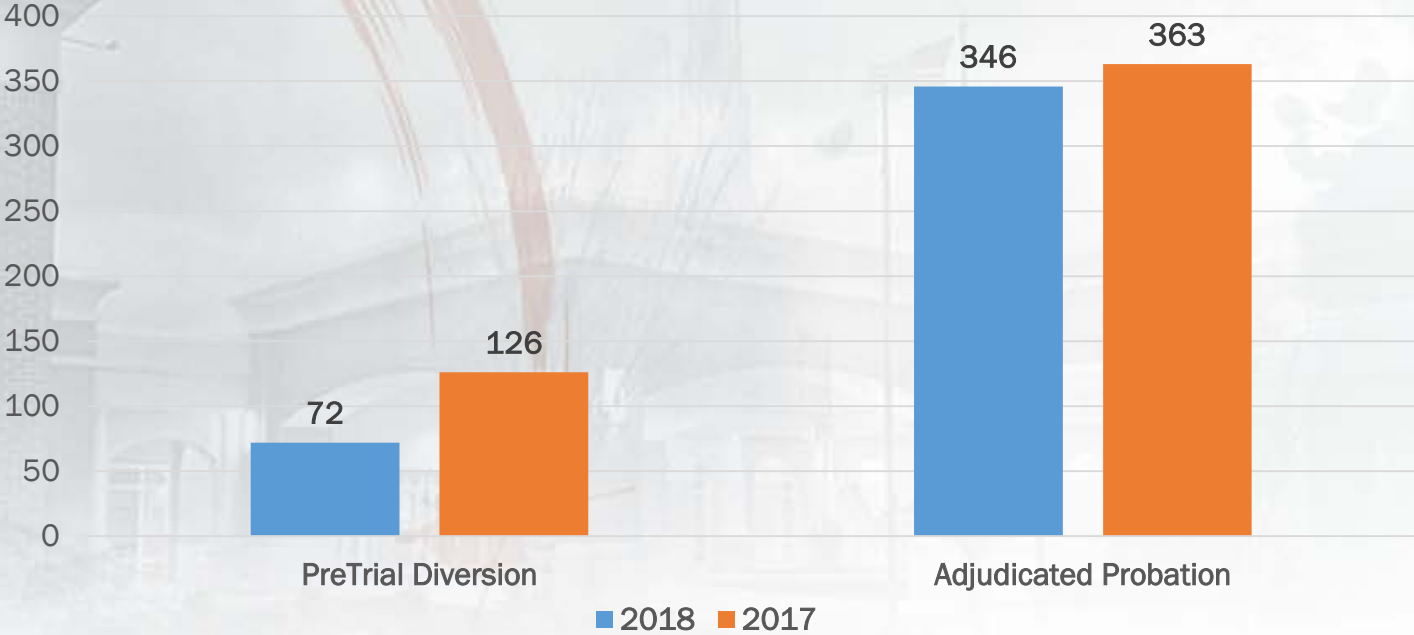

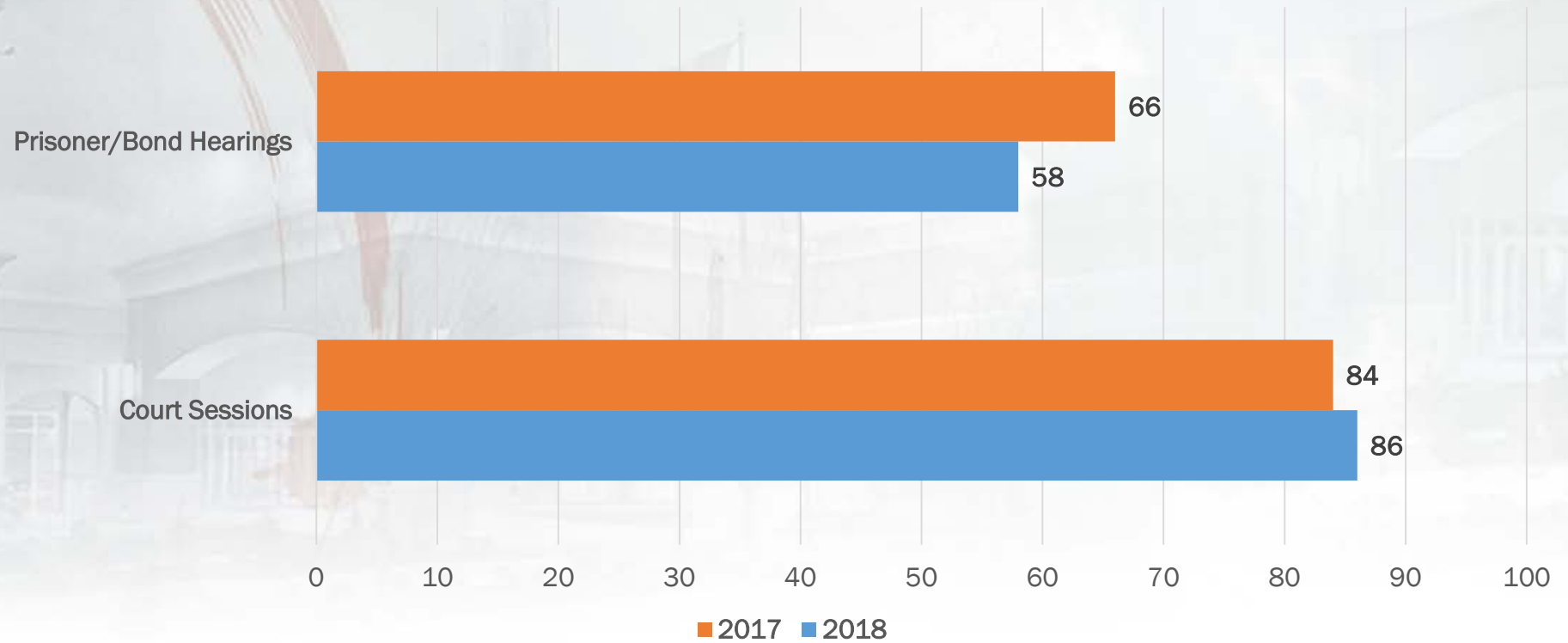


# Number of Court Days

2018 versus 2017

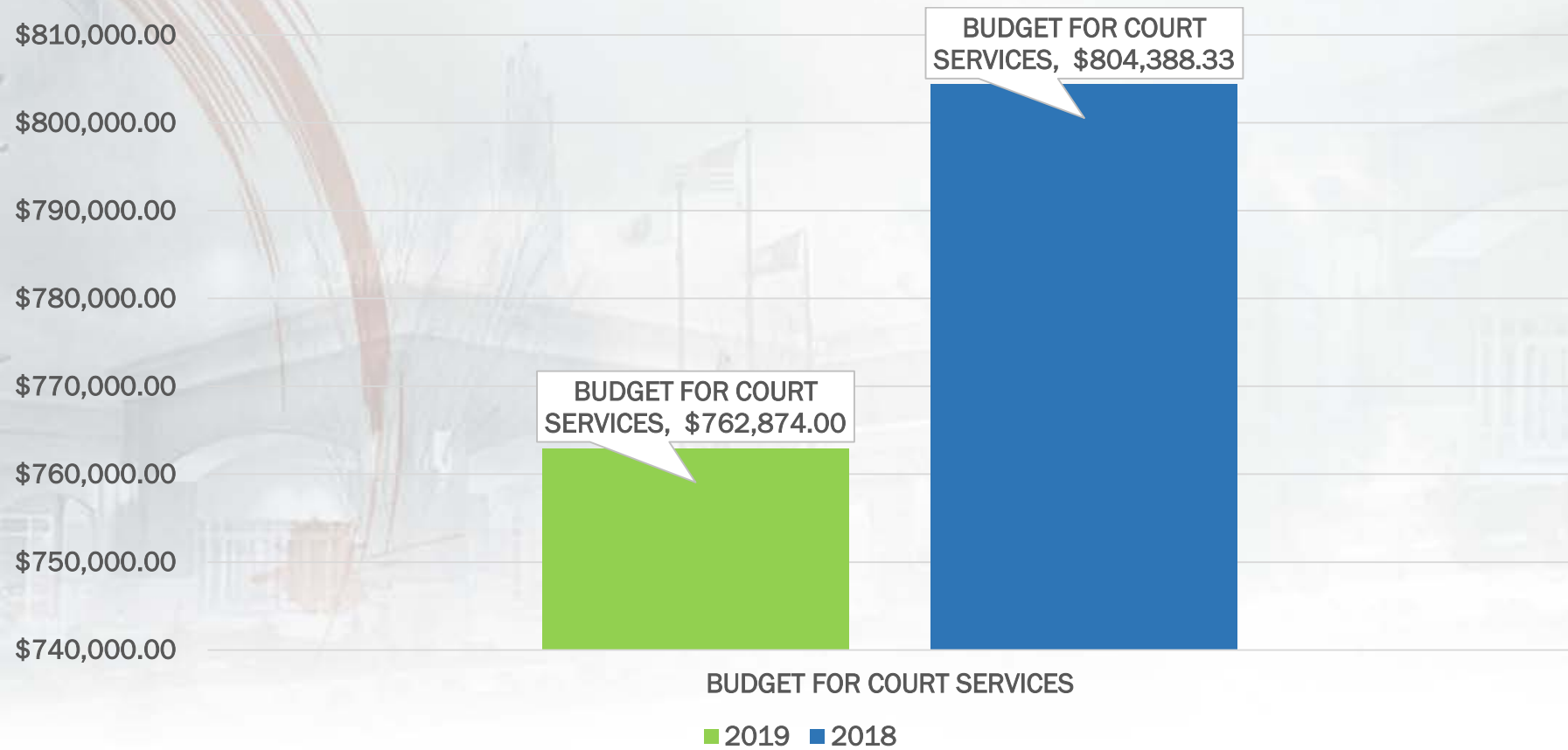

# Changes to Court Services Under New Court Administrator

- Added a civilian bailiff position to Court Services.
- Made Solicitor a full time contract position – 13 days a month.
