Each person desiring to qualify must submit a candidacy affidavit for the position sought and pay the appropriate qualifying fee for the position, which are \$1,188.00 for the office of Mayor and \$387.00 for the office of Councilmember.

Residents of the City of Douglasville wishing to vote in the November 7, 2023 election but who are not registered electors of the City may register to vote through October 10, 2023.

Early voting by absentee ballots will be held Monday through Friday at the Voter Registrar's Office, first floor, Douglas County Courthouse, 8700 Hospital Drive, beginning Monday, October 16, 2023, and continuing through Friday, November 3, 2023, between the hours of 9:00 am and 5:00 pm each day, and by mail. The first day to submit an absentee ballot application will be Monday, August 21, 2023, and the last day to submit an absentee ballot application is Friday, October 27, 2023.

Advance voting will begin Monday, October 16, 2023, and continue through Friday, November 3, 2023, at the same place and times. Mandatory Saturday Voting will be held on Saturday, October 21, 2023, and Saturday, October 28, 2023.
