

SUBMITTAL REQUIREMENTS Commercial - New or Addition

Construction of a new commercial buildings including mechanical, electrical and plumbing work will require the following documents to be submitted for full review by City of Douglasville staff. Separate permits are required for the mechanical, electrical and plumbing scopes of work and cannot be issued until the building permit is issued but the information for those scopes should be proposed on the main sets of Permit Documents. A separate demolition permit can be obtained as an optional phase of construction otherwise it will be considered a portion of the main building permit.

Separate permits and reviews are required

- Mechanical (PM), Electrical (PE) and Plumbing (PP)
- Plat permits for combining or separating a parcel
- Commercial Pool Permits (PP)
- Land Disturbance and Development (LDP)
 - Side sewer connection and water meter installations are not included in this process and will need to be obtained from Douglas County Water and Sewer Authority (DC-WSA) prior to applying for a permit.
 - Properties over 5,000 SF in square footage require an Automatic Fire Sprinkler system which will be reviewed by the Douglas County Fire Marshall (DC-FM). The plans below will need to be submitted to The City of Douglasville and will then be routed to DC-FM.

Projects that Require Plan Review: must have the following documents submitted to the Douglasville Building Department for full review. A Plan review fee of \$125.00 will be required at intake of documents. See applicable Plan Review Checklists for further information
