a. Division Update


1. Administration

- i. The Assistant Director vacancy has been filled by Chris Bass.
- ii. The Parks and Recreation Strategic Plan will be published at the end of the month. A survey was sent out to advisory board members and community partners to provide input in the plan.

2. Recreation/Facility Operations

- i. The Hawthorne Center renovations are 80% complete. The last phase includes redesign of the lobby and resurfacing of the basketball court.
- ii. The outside basketball courts at Jessie Davis are 90% complete.
- iii. Tennis Court conversion with the old tennis courts in out for bid. Half of the courts will be converted to basketball courts and the other half will be converted to a soccer field.
- iv. Outdoor exercise equipment is being installed at Hunter Park. This weatherized equipment will be placed on the left side facing the Ike Owings building opposite of the playground.
